These Scholarships will depend on the number of students in each stream and class attendance 70% as given below:-

- For No. of students upto 30 – First 03 positions only.
- For No. of students upto 60 – Top 05 positions only.
- For No. of students upto 120 – Top 10 positions only from position 06 to 10 scholarship of 10% each.
- For more than 100 – Top 10 position as per criteria (c) and 11– 25 positions scholarship of 10%.
- Subject to number of admissions at First Year in particular Department/School.

6. SCHOLARSHIP FOR PG STUDENTS:-

Scholarship of 25% as a Fee Concession to the students seeking admission in all Post Graduate Courses for those who passed UG courses for BBDU/BBDITM/BBDNIIT/BBDEC. This will be effective for First Year only.

7. SCHOLARSHIP FOR Ph.D. STUDENTS: (For whole Ph.D. Program):-

Scholarship of 25% as a Fee Concession to the Faculty of BBD Educational Group seeking Admission in Ph.D Program.

This Scholarship will also be applicable for internal Post Graduate students.
