6. Affidavit for gap period, Non Judicial Stamp Paper of Rs. 50/- as applicable.
7. Photograph of Bank Passbook of the student showing Savings Fixed Bank Account Number.
8. Photograph of Ean Receipt of the student for the year 2021-22.
9. Aadhar Card (Mandatory).
10. Self declaration of Community by the student (Mandatory).
11. In case of "Fresh" Self attested Certificate of "Previous Academic Mark Sheet" as filled in form (Mandatory).
12. In case of "Renewal" Self attested Certificate of "Previous Academic Mark Sheet" as filled in form (Mandatory).
